- 4. to further the contact between the student and the University of Applied Sciences Ulm during the practical semester.
- 5. to co-operate with the University of Applied Sciences Ulm in all guestions affecting the education of the student,
- 6. to review the report to be drawn up by the student,
- 7. to issue a certificate furnishing information about the successful completion of the practical training period as well as possible times of absence from work.
- (2) The student undertakes to conduct himself in keeping with the envisaged training purpose, chiefly by
  - 1. availing himself of the training opportunities offered to him, and in doing so observing the regular daily work hours of the company concerned,
  - 2. performing with due care the tasks assigned to him within the framework of the training schedule,
  - 3. complying with orders and instructions given to him by persons entrusted with the supervision of his practical training,
  - 4. observing all regulations valid at the company, above all work and safety regulations as well as instructions relating to professional discretion,
  - 5. drawing up a report within a period prescribed and in accordance with the pertinent directives as issued by the faculty.
  - 6. immediately notifying the company of any absence from work, and presenting medical certificate in case of illnesses on the 3rd day at the latest.

# § 3 Practical training deputy

The company appoints Mr./Mrs.\_\_\_

\_ (name, phone, fax) as deputy for the training of the student. This person also acts as a contact for the student and the faculty in questions concerning the contractual relationship.

## § 4 Vacation / Interruptions of the practical training

The student is not entitled to a vacation during the period of practical training. The company may, however, grant a short leave for personal reasons. Other interruptions must as a rule be made up for.

## § 5 Cancellation of the contract

The practical training contract may be cancelled prior to its expiry

1. for important reasons (without a deadline),

2. by both parties subject to a deadline of 4 weeks in case of relinquishment or alteration of the training objective or due to personal reasons.

The cancellation is effected by a written statement of one party to the other. The University of Applied Sciences Ulm is to be notified immediately by the party demanding the cancellation.

# § 6 Insurance coverage

During a practical semester abroad, the students themselves have to take care of an appropriate health, accident and personal liability Insurance.
